## 1. BACKGROUND

This report describes the analytical testing of a CBD sample product labelled as menthol repair balm.

The term "CBD" is an acronym for cannabidiol, which is one of several cannabinoids, or chemical compounds, that are found in cannabis and hemp plants.

The sample was analysed for the concentrations of 7 cannabinoids:

- CBC, Cannabichromene
- CBD, Cannabidiol
- CBDA, Cannabidiolic acid
- CBG, Cannabigerol
- CBN, Cannabinol
- THC, Tetrahydrocannabinol
- THCA, Tetrahydrocannabinolic acid

#### 2. SAMPLE DESCRIPTION

The sample was received at the laboratory in satisfactory condition and stored dark at ambient temperature prior to analysis.

The sample was in a 30 mL glass pot with a clear plastic screw cap. The customers identification information was displayed on a sticker on the side of the pot.

A unique identifying number was assigned to the samples using the Fera laboratory information management system. The relevant sample details are shown in the table below.

#### 3. SAMPLING AND ANALYSIS

#### 3.1 Cannabinoids

The sample was extracted into solvent and diluted before the cannabinoids were determined using LC-UV.

Accuracy of the method was assessed by analysing in-house reference material with known concentrations of CBD as well as over spiked blank material alongside the samples.

4.1 Cannabichromene, cannabidiol, cannabidiolic acid, cannabigerol, cannabinol, tetrahydrocannabinol and tetrahydrocannabinolic acid
